

PLATINUM SUMMER SWEEPSTAKES- \$50 GAS GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: To enter the Platinum Summer Sweepstakes (the "Sweepstakes"), you must be a lawful permanent resident of the United States, 18 years of age or older with a unique, personal and valid social security number and must not be considered a minor in your state of residence. Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. Employees and volunteers of Weber State Credit Union and their immediate families (i.e. parents, children, siblings, spouse) and members of their households (whether related or not) are ineligible to participate in this Sweepstakes.

HOW TO ENTER: The Sweepstakes begins at 12:01 a.m. (Mountain Standard Time ["MST"]) on June 16, 2008 and ends at 11:59 p.m. MST on September 14, 2008 (the "Sweepstakes Period"). There are three ways to enter the Sweepstakes.

1. Sign up for a new VISA Platinum card : Every approved new Weber State Credit Union VISA Platinum application will be considered one entry into the weekly Sweepstakes. All WSCU VISA Platinum cards are eligible for the promotion (includes VISA Platinum Rate Advantage, Rewards, and Cash-Back cards.) Members with an existing VISA Platinum card in their account may not be considered for the drawing. Drawing entries are valid only for the week in which the application was submitted, and will not be considered in subsequent weekly drawings.

2. Mail Entry: On a plain 3" x 5" card, legibly handprint or type your name, age, complete address, city, state, zip code, home phone number.
